Monthly Report

Report of Trade Defence Wing (TDW) for the month of July 2021.

Submission of Questionnaire responses:

During the month of July, 2021, Trade Defence Wing (TDW) submitted questionnaire responses in the following Countervailing Duty (CVD), Anti-Dumping Duty (ADD) Investigations initiated by other WTO member countries against exports from India:

- a. On July 01, 2021, TDW submitted Government of India (GOI) response before the United States Department of Commerce (USDOC) to third supplementary questionnaire issued in Countervailing Duty (CVD) Investigation on *Granular Polytetrafluoroethylene Resin (Granular PTFE Resin)* (C-533-900) exported from India.
- b. On July 12, 2021, TDW submitted GOI response before the USDOC in the Administrative Review of the CVD orders on *Carbon Steel Flanges* (C-533-872) exported from India
- c. On July 13, 2021 TDW submitted GOI response before the USDOC in the Administrative review of CVD orders on *Cold Drawn Mechanical Tubing* (C-533-874) exported from India.
- d. On July 20, 2021, TDW submitted GOI response before the USDOC in the Countervailing Duty Investigation on *Organic Soybean Meal* (C-533-902) exported from India. TDW also sought partial extension from the USDOC for filing of the response with respect to the following programs:
 - i) State Government of Madhya Pradesh (SGMP) Subsidy Programs,
 - ii) Subsidies for Export-Oriented Units (EOUs),
 - iii) Benefits for Special Economic Zones (SEZ)
- e. On July 26, 2021, TDW submitted the remainder partial GOI response before the USDOC in the Countervailing Duty Investigation on *Organic Soybean Meal* (C-533-902) exported from India.
- f. On July 20, 2021, TDW submitted Case Brief on behalf of GOI before the USDOC in Countervailing Duty Investigation on *Utility Scale Wind Towers* (C-533-898) exported from India.

- g. On July 27, 2021, TDW submitted GOI response in the New Subsidy Allegation (NSA) Questionnaire before the USDOC in the Administrative Review of Countervailing Duty Investigation on *Glycine* (C-533-884) exported from India.
- h. On July 27, 2021, TDW submitted the GOI comments on the Essential Fact Disclosure Document issued by the Ministry of Economy, Brazil (SDCOM) in the Countervailing Duty Investigation on *PET Films* exported from India.

Meetings/Consultations held/participated

a. On July 12, 2021 TDW officials participated in the public hearing conducted by the Ministry of Economy, Brazil (SDCOM) in the *CVD PET Films* Case. The written submissions were subsequently filed on July 27, 2021.

<u>Initiation of Trade Remedy investigations against India and issue of questionnaires:</u>

During the month of June, 2021, following CVD, ADD investigations were initiated by other WTO member countries:

- a. On July 13, 2021, Indian High Commission informed that the Canada Border Service Agency (CBSA) initiated an expiry review investigation on *Certain Flat Hot-Rolled Carbon and Alloy Steel Sheet and Strip* originating/exported from India.
- b. On July 23, 2021, the Indian embassy, Brussels informed TDW that the European Commission issued a GOI questionnaire in the Review proceeding of Anti-subsidy investigation concerning imports of Tubes and *Pipes of Ductile Cast Iron* (R737).
- c. On July 29, 2021, the USDOC issued a New Subsidy Allegation (NSA) Questionnaire on Countervailing Duty Investigation on *Organic Soybean Meal* (C-533-902) from India.

<u>Issuance of final/provisional findings against exports from India:</u>

During the month of July, 2021, following provisional/final findings were issued by other WTO member countries in investigations against exports from India:

a. On July 07, 2021, the USDOC issued Preliminary Results of Countervailing Duty Administrative Review; 2019 of *Glycine* (C–533–884) from India and imposed the following anti-subsidy rates:
