Report of Trade Defence Wing (TDW) for the month of November, 2021.

Submission of Questionnaire responses:

During the month of November, 2021, Trade Defence Wing (TDW) submitted questionnaire responses and note verbale in the following Countervailing Duty (CVD) and Anti-Dumping Duty (ADD) investigations initiated by other WTO member countries against exports from India:

- a. On November 09, 2021, TDW submitted Supplemental Questionnaire Response before the United States Department of Commerce (USDOC) in the Administrative Review (for the Calendar year 2020) of CVD orders on *Cold Drawn Mechanical Tubing* (C-533-874) from India.
- b. On November 18, 2021, TDW submitted Case Brief in CVD investigation before the USDOC (for the financial year 2019-20) on *Granular Polytetrafluoroethylene Resin* (PTFE Resin) (C-533-900) from India.
- c. On November 24, 2021, TDW partially submitted Initial Questionnaire Response before the USDOC in Administrative Review (for the calendar year 2020) on *Glycine* (C-533-884) exported from India.
- d. On 29 November, 2021, TDW submitted questionnaire response in Refund Investigation for the period 1 July, 2018 to 31 March, 2020, conducted by the European Commission on Tubes *and Pipes of Ductile Cast Iron* (RF 75/13-32) exported from India.

Initiation of Trade Remedy investigations against India and issue of questionnaires:

During the month of November, 2021, following Countervailing and Anti-Dumping investigations were initiated by other WTO member countries:

- a. On November 19, 2021, the USDOC issued Initial Questionnaire for Administrative Review (for the Calendar Year 2020) of CVD orders on *Polyethylene Terephthalate (PET) Film* (C-533-825) exported from India.
- b. On November 19, 2021, Anti-Dumping Commission, Australia initiated an Exemption Inquiry (No. EX0088) on Zinc Coated (galvanised) Steel exported from India, China, Malaysia and Vietnam.

Issuance of final/provisional findings against exports from India:

During the month of November 2021, following provisional/final findings were issued by other WTO member countries in various investigation against the goods exported from India:

a. On November 1, 2021, the USDOC released Preliminary Results of Administrative Review (for the calendar year 2019) of Countervailing Duty on *Stainless Steel Flanges* (C-533-878) and imposed the following subsidy rates: -
